Spokane Figure Skating Club - Rules Governing Tests

- If you are <u>not</u> a member of *Spokane FSC* ("SFSC"), there is a "non-member" fee of \$20 to be added to the total test cost. As a "non-member," you are responsible for obtaining a *permission letter* from your home club and submitting it with your test application (an e-mail from the Test Chair of your home club is acceptable). If you choose to join *SFSC* as an "associate" member, that would waive the "non-member" fee of \$20.
- 2. The test candidate must be a member in good standing of U.S. Figure Skating.
- 3. Test applications are due three weeks before the test date (you don't want to have to pay the \$20 late fee).
- 4. Test applications will be processed in the order received; however, first priority is given to home club members, and second priority to associate members. Should the test session fill before the application deadline, all other test applications will be held and given first priority at the next scheduled test session.
- 5. Test fees are **NON-REFUNDABLE** unless the following conditions are met: (a) *SFSC* is unable to accommodate your test on the date requested due to time allotted for test session (b) candidate or partner is injured or ill, in which case we require a written excuse from your doctor.
- 6. Test fees will not be carried over to the next test date if skater is unable to advance to FS due to a retry mark on MITF or unable to advance to a higher level dance due to a retry mark on a dance.
- 7. Checks are payable to *Spokane FSC*. A fee of \$25 will be due for any check returned for insufficient funds.
- 8. Your coach will know when you are ready to take your test(s). Be sure to have your coach sign the test application form.
- 9. Be at the rink one hour before your test is scheduled to begin. The test schedule will be e-mailed to you 7 days before the test session (make sure your e-mail is accurate and clearly written); it will also be posted on the *SFSC* website at http://www.spokanefigureskating.org.
