## Aspen Skating Club Testing Terms and conditions

## Terms effective September 2018

1. Applications must be received by the deadline. Completed applications include: Page 1 and 2 of test application, USFS Permission Form if not an ASC member, and total test fee. Failure to provide any of the previous constitutes an incomplete or late application. LATE APPLICATIONS WILL ONLY BE ACCEPTED WITH APPROVAL OF THE TEST CHAIR AND WILL BE CHARGED A \$25.00 LATE FEE. THERE ARE NO EXCEPTIONS.

2. USFS Number is required on the application. The only exception is if the member is new and testing for pre-preliminary and has not received their number from the USFS. In this instance please put "PENDING" in place of the number.

3. Schedules will be posted on the club's bulletin board at Lewis Arena a minimum of one week before the test date. This schedule is subject to change and it's the skater or parent's responsibility to check for changes. Posted changes will be considered sufficient notice up to the day before the test.

4. Test fees will not be credited or refunded for canceled tests after the test deadline except in documented cases of illness, injury or a death in the immediate family. Fees will then be held and credited to the next test session.

5. Please be at the rink a minimum of 40 minutes before your scheduled test time and be prepared to test at any time. Cancelled tests can cause the test session to run ahead of schedule and if you are not prepared to test when called, we waste ice. We will not hold a test because it is running ahead of schedule. Not being ready for your test when called upon or an inconvenient test time is not grounds for refund.

6. Special requests will be granted only if the test chair is able to accommodate. If the special request involves the club having to purchase additional ice time, the skater will be accountable for the additional cost in addition to the test fee. We remain committed to keeping the rates as low as possible and we will make every effort to maximize the use of ice available to us by running multiple tests with more than one panel of judges whenever that is feasible or permissible, within bounds of USFS guidelines, while maintaining a quality testing environment.

7. If you are planning to take a Junior or Senior MIF, Freestyle test, or any dance test, please notify the test chair 30 days in advance. This will give the test chair the opportunity to contact the qualified judges for those tests. The test chair reserves the right to cancel tests due to lack of appropriate judges.

8. If you are scheduled to take a MIF test and a Freestyle test at the same level on the same day and you do not pass the MIF test you will not be given a refund. The test fee for the Freestyle test will be credited until you are able to pass the MIF test.

9. All skaters must pay a hospitality fee of \$15.00 per test session. This fee is to cover the costs of hospitality for judges, coaches, and skaters.
