Membership for skating season from 7/1/20 to 6/30/21 opens on June 1, 2020!

READ and SAVE this entire note which includes examples for entering your membership into EntryEeze.

An adult or parent/guardian must join the club with any skater under the age of 18 unless the skater is registering for the Learn to Skate Program. All participants in the Learn to Skate program MUST sign up as Learn to Skate membership.

Below are the membership categories and fees, followed by some examples. Some of the category names have been revised.

- \$125 Minor Skater with Parent/Guardian (two memberships) [previously called Junior]-this membership is for skaters under the age of 18 and their parent/guardian. The minor skating member will have all member privileges, except the right to vote at the annual meeting. The parent/guardian member will have all member privileges including attending and voting at the NJFSC annual meeting.
- **\$100** Adult Skater (previously called Senior) -this membership is for <u>individual skaters and non-skaters</u> who wish to support the club who are over the age of 18. This member has the privilege of attending and voting at the NJFSC annual meeting.
- **\$50** Additional Family Member-this membership is for family members of club members already registered in other categories. **Do not use for Learn to Skate**. These memberships can be skating or non-skating. If the additional member is 18 years old or older they can vote at the NJFSC annual meeting.
- **\$120** Collegiate -this membership is for currently enrolled college students. This membership is good for four years and can be purchased one time only. Proof of full-time student status is required. If the member is 18 years old or older, the members have the privilege of attending and voting at the NJFSC annual meeting.
- \$85 Introductory Minor Skater with Parent/Guardian (two memberships)-this membership is available to skaters under the age of 18 and their parent/guardian for one year only, to first time USFS members. The minor skating member will have all skating member privileges except the right to vote at the annual meeting. The parent/guardian member will have all member privileges including attending and voting at the NJFSC annual meeting.
- **\$70 Skating Professional** -this membership is for professional skating instructors, even those who instruct only basic skills skaters. This membership has the privilege of attending and voting at the NJFSC annual meeting. All skating professionals must be at least 18 years old.
- **\$100 Second club (Associate Member)** -membership benefits are restricted to discount testing fees and eligibility to skate on NJFSC sponsored ice. This membership is for skaters with another home club.
- \$45 Learn To Skate -this membership is for skaters participating in USFS Learn to Skate program. These skaters do not have voting rights at the NJFSC annual meeting and cannot register for test sessions. If the skater intends on taking a USFS test this season, please select Introductory Minor Skater with Parent Guardian.

Complimentary Lifetime service and Complimentary memberships - this membership category is available to a small number of individuals selected by the NJFSC board officers based on their extraordinary service to the club or to US Figure Skating. Examples of people who can request this category are Judges, US Figure Skating Officials, club officers. These complimentary memberships include full USFS membership and the privilege of attending and voting at the NJFSC annual meeting. EXAMPLES:

- 1. <u>Skater (under 18)</u>: Choose <u>Minor Skater with Parent Guardian</u> and enter child's data. Then choose <u>Minor Skater</u> again and enter the adult information. Total cost at checkout for 2 will be \$125. **DO NOT choose Adult or Additional Family Member for the parent/guardian!**
- 2. Individual skaters or non-skaters (18 and older): Choose Adult Skater for \$100.
- 3. For more skaters or adults in one family, where no one is Learn to Skate: After following example 1 or 2 for your primary skater (and required adult), choose <u>Additional Family Member</u> for \$50/person. A family of 4 with any skater under the age of 18 would enter 1 child and 1 parent in Minor Skater category and the other 2 family members as Additional for a total cost of \$125 + \$50 + \$50 = \$225.
- 4. <u>For a family with multiple skaters and at least one Learn to Skate participant</u>: Follow the examples above with the following exception: the Learn to Skate skater must be entered using the Learn to Skate category not any other category.
- 5. <u>Skating Professional with skating minor child</u>: The most cost effective option is to choose Skating Professional for parent at \$70 and Additional Family Member for the child at \$50, totaling \$115.
- 6. If the skater is <u>under age 18 and have never had a USFS membership and the skater intends in participating in</u> a test session: Choose Introductory Minor Skater with Parent/Guardian. Total cost for the 2 will be \$85.
