



## Bremerton FSC Club Equipment Use Policy 2021 – 2022

**Use of club owned equipment is a membership benefit and is restricted to those members with current Individual, Introductory Individual, Family, Family Introductory, Associate, and Professional memberships. Crossover and Supporting Adult members do not have this benefit.**

Bremerton FSC owns various equipment, including but not limited to:

<sup>1</sup>On and off-ice harnesses may only be used under the supervision of a credentialed coach with a current Bremerton FSC Professional membership.

<sup>2</sup>Skaters may use off-ice edge trainers, off-ice spinners, Champion cords, and jump ladder independently, once they have been introduced to this equipment by a credentialed coach with a current Bremerton FSC Professional membership.

Requirements for use of Training Equipment:

- Training Equipment must be checked out on the sign-out sheets in the equipment cabinet.
- Training equipment must remain in the Bremerton Ice Center building at all times.
- Coaches with Professional memberships may remove equipment for a maximum of one week.
- If equipment is to be used during a lesson, class, or camp, both the coach/instructor and skater must have current eligible memberships. It is the responsibility of the member(s) using the equipment to confirm eligibility prior to use.
- Member is responsible to return any equipment checked out.
- Member is liable for damage to or loss of equipment, including all costs necessary to repair or replace equipment.
- If there is a malfunction or damage to equipment, member must immediately inform a coach or board member and complete a Damage Report.

Requirements for use of Skating Performance Equipment:

- Skating Performance Equipment will be checked out using a “Skating Performance Equipment Request” form.
- Member is responsible to return any equipment checked out by the agreed upon date or obtain an extension in writing.
- Member is liable for damage to or loss of equipment, including all costs necessary to repair or replace equipment.

Exceptions to this policy may be granted for Bremerton FSC Crossover members and non-member skaters who are members of US Figure Skating, for training equipment use during a lesson, class, or camp supervised by a credentialed coach with a current Bremerton FSC Professional membership.

- All exceptions must be approved by the board **prior** to use, using a “Club Equipment Use Request” form.
- Non-members granted exceptions are required to sign a club “Waiver and Release of Liability, Assumption of Risk & Indemnity Agreement” and “Consent for Medical Attention or Treatment” **prior** to use of equipment.
- Exceptions may be requested for a maximum of four (4) calendar days during a club year. Non-members and Crossover members seeking exceptions in excess of four days should, instead, purchase an Associate membership.
- A fee of \$10 per calendar day for equipment use is **due in the club box the day of use.**

US Figure Skating member skaters and US Figure Skating credentialed and insured coaches visiting at the invitation of the club for seminars or performances, will be permitted use of club equipment at no fee.

**Waiver and Release of Liability, Assumption of Risk & Indemnity Agreement**

In consideration of participating in Bremerton Figure Skating Club (BFSC) activities, I represent that I understand the nature of figure skating activities (“activity”) and that I am qualified, in good health and in proper physical condition to participate in such “activity”. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the “activity”.

I fully understand that this “activity” involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the “activity”, the conditions in which the “activity” takes place, or the negligence of the “releasees” named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the “activity”.

I hereby release, discharge, and covenant not to sue the Bremerton Figure Skating Club, United States Figure Skating, it’s directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the “activity” takes place (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

The Bremerton Figure Skating Club has the right, but not the obligation, to provide rules, regulations and/or ice monitors for BFSC sponsored ice. We hereby acknowledge that the Bremerton Figure Skating Club shall not be responsible for the supervision of the members at BFSC sponsored ice.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, and understand that I have given up substantial rights by signing my agreement on the BFSC Membership Application and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

**Skaters:**

1. Check "Eligibility List" to make sure:
  - your membership is current
  - your membership includes the use of club equipment
  - your coach has initialed that you have been introduced to the equipment you want to check out
2. Check-out the equipment below.
3. Return the equipment when you're done.

**Coaches:**

1. Check "Eligibility List" to make sure:
  - your membership and the membership of any skaters you plan to use the equipment with are current
  - the membership of any skaters you plan to use the equipment with includes the use of club equipment
  - If skater is not shown as eligible on list, check for an **approved** "Club Training Equipment Use Request" form for your skater. If there is not one, skater may not use the equipment.
2. Check-out the equipment below. If you are checking out for an extended period (up to one week) indicate the date to be returned.
3. Return the equipment when you're done.
4. Initial the appropriate place for any skaters that have been newly introduced to training equipment so they may check it out independently in the future.
5. Remind skaters who were using the equipment with an approved exception (non-members and Crossover members) to pay the \$10 day-use fee to the club box prior to leaving that day.
