2. Assumes all foregoing risk and accepts personal responsibility for the damage following such injury, permanent disability or death.
3. Releases, waives and discharges not to sue Kettle Moraine FSC, it's affiliated organizations, their respective administrators, directors, board members, coaches, volunteers, other participants, sponsoring agencies, and/or advertisers, all of which are hereinafter referred to as "releases" from all liability to each of the following, Payor, student and parents/guardians, his/her heirs and next of kin for any and all claims, demands, losses or damages on account on injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
