#### INSTRUCTIONS FOR MEMBERSHIP RENEWAL AND REGISTRATION

#### **RENEWALS for CURRENT members**

**NOTE:** If you are adding a new skater to an existing family, renew current members first. Then add new family member following Registration instructions that follow below.

- 1. Go to our Membership site at <a href="http://comp.entryeeze.com/Membership/Welcome.aspx?cid=324">http://comp.entryeeze.com/Membership/Welcome.aspx?cid=324</a>
- 2. Click on Access My Account and login with email address and password.
  - Follow steps to reset password if forgotten. Record new password.
  - If you have technical issues and cannot login, contact fefsc@fefsc.org.
- 3. Click RENEW (begin with Primary member).
- 4. Ensure all personal information is current; update as needed.
- 5. Provide coach information, if applicable.
- 6. IMPORTANT: from drop down box, select correct Membership Type for renewal.
  - Refer to this Planning Form or the descriptions provided on the site.
- 8. IMPORTANT: fully read and "sign" Mandatory Volunteer Requirements.
- 9. Read and "sign" Waiver and Release, and Consent.
- 10. Repeat this process until all members in family have been renewed.
- 11. Go to Shopping Cart and process payment for renewals. Renewal will not be completed until payment is made.

#### **REGISTRATION for NEW or transferring members**

- 1. Go to our Membership site at http://comp.entryeeze.com/Membership/Welcome.aspx?cid=324
- 2. Click on Apply for Membership and follow proper prompts.
- 3. Enter personal information. If you do not have a USFS or Basic Skills number, leave this blank (you will receive one later).
- 4. Once your account has been established, you will receive an email to validate your account.
- 5. Validate account with link in email, Login and create password (record it somewhere).
- 6. If there is an additional family member, "Add New Family Member" and follow prompts.
- 7. Once personal information is recorded for all family members, click on APPLY/RENEW tab.
- 8. Select correct Membership Type for each person. (IMPORTANT: Refer to this Planning Form or the descriptions provided on the site.)
- 9. IMPORTANT: fully read and "sign" Mandatory Volunteer Requirements.
- 10. Read and "sign" Waiver and Release, and Consent.
- 11. Repeat this process until all family members have been registered.
- 12. Go to Shopping Cart and process payment for registration. Applications will not be completed until payment is made.

#### **Membership Notes:**

Membership is based on the Club year July 1st - June 30th. • There is no pro-rating of membership fees regardless of date membership is entered, so join early! • Memberships are subject to approval of the FEFSC Board of Directors. • Members must pay their entire membership fee prior to submitting applications for competitions or testing. • Visit USFSA.org for more information about USFSA Membership benefits, and fefsc.org for more information about our Club.

#### **Mandatory Volunteer Requirements or Service Levy:**

Per Florida Everblades Figure Skating Club membership rules, each FEFSC member (except Associates, Judges, Officials, Professionals, and Sponsors – although their help is never turned down!) is required to fulfill volunteer requirements for the Florida Everblades Figure Skating Club during the membership period of July 1st through June 30th.

Members, or family members of the member, <u>must volunteer a minimum of 10 hours per year</u> (subject to <u>change</u>). The hours may be served during test sessions and competitions, during either of our Shows, or at another event. We will give ample opportunities for hours to be fulfilled! Some volunteer opportunities require that the volunteer be SafeSport Certified and/or have a Background Check. While we do have plenty of opportunities available that do not require this, any job that allows contact with skaters under the age of 18 will require that one has the certification/background check.

While not preferred by the club, those families who wish to have the volunteer hour requirements waived must pay a fee of \$200 at the beginning of the membership year. This option can be found in the "Donation" tab in your membership account.

Volunteer hours not served by the end of the fiscal year (July 1st) will be assessed a charge of \$20 per hour. Any monies received in lieu of volunteer hours will go into the general fund and will be put towards club expenditures including judges travel expenses, food for events, ice time, coaching fees for shows, etc.

Florida Everblades Figure Skating Club relies on its volunteers to keep our costs at a minimum. Any spare time that members and their families can donate will help to ensure the continued growth and success of our club. We appreciate all of your help and look forward to a great year!

There are many areas of service in which to contribute your hours. We understand that calendars and circumstances change and you may be able to help out more later in the year. We will be sending out email and Facebook reminders asking for volunteers throughout the year. Remember, many hands make light work!

\*\* As allowed by our Bylaws, if this volunteer requirement is not met nor the monetary service levy paid, the Member is subject to a "poor standing" status and certain privileges (i.e.: testing, seminars, etc) may be denied and/or membership will be subject to non-renewal. \*\*
