1. COMPETITION OVERVIEW

The 2024 Spring Jubilee competition will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the [current rulebook](#), and/or current Compete USA handbook as well as any pertinent updates that have been posted on the U.S. Figure Skating [website](#).

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, Learn to Skate USA® member, a collegiate club or an individual member in accordance with the current rulebook. For non-U.S. citizens, please refer to the [rulebook](#) for more information.

SERIES INFORMATION:

Spring Jubilee has been approved by US Figure Skating to be part of the 2024 National Solo Dance Series and the 2024 Excel Series. Please refer to the respective Series handbooks for the current rules, eligibility, music, costume, and event requirements.

II. ELIGIBILITY

Singles: Excel and Well-Balanced Events:

- Skaters must meet at least the minimum singles test requirements for the event's level. A skater's singles test level may be higher than the minimum requirement.
 - o Skate Up: skaters may skate up one level higher than their minimum test requirement allows.
- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
 - o If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
 - o If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
 - o If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met.
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate). However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

All other singles and partner events (such as Adults, Pairs, Ice Dance):

- Skaters must meet the minimum test requirements for the events level, but not exceed the maximum permissible test requirement.

Please note:

- The skater's test level for minimum test level requirements will be the skater's test level as of the entry deadline (April 18, 2024).
- The skater's age for age-restricted events will be skater's age as of the entry deadline (April 18, 2024).

COMPLIANCE:

COACHES

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA® Instructor Compliance. Details regarding compliance requirements can be found [HERE](#). All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

Coaches of foreign athletes: If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

TEAM SERVICE PERSONNEL

Teams are permitted a maximum of two team service personnel. Team service personnel must have a current U.S. Figure Skating membership, a green lighted background check and completed SafeSport™ Training. All compliance requirements must be met at the time of check-in to access the competition, no exceptions. Team service personnel is defined as those indicated as a team manager and/or team service personnel planning to attend the competition with the team.

MANDATORY ATHLETES

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, shadow dance, theatre, etc.) with at least one Minor Athlete must complete SafeSport™ Training. Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport™ Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. Please email skatesafe@usfigureskating.org for instructions or questions regarding parental consent.

III. REGISTRATION INFORMATION

Late Entries will be allowed at the discretion of the Chief Referee and a one-time late fee of \$50 will be assessed at checkout. Skaters with late entry requests must email their music and PPC (if applicable) to the Registrar to be considered for registration.

Late fees will not be removed under any circumstances and must be paid by May 3, 2024, 11:59 p.m. (PDT). If a skater has any unpaid fees, including late fees, after that date, the Local Organizing Committee may withdraw the skater, without refund, from all entered events.

The Chief Referee reserves the right to close registration at any time if competition entries exceed the time allotted for the competition.

ONLINE REGISTRATION VIA EMS:

Online registrations will be accepted via [EMS](#) for **Excel Series and NSDS Series events only**. Payment must be made at the time of registration by credit card only. Each transaction includes a 3% transaction fee.

Skaters who register for an Excel free skate (EMS) or National Solo Dance Series event and any event in EntryEeze should contact the Registrar *prior to* registering for EntryEeze events to receive 2nd / 3rd + event pricing. **NO REFUNDS OF ADDITIONAL CREDIT CARD PROCESSING FEES INCURRED DUE TO OVERPAYMENT OF 2nd / 3rd EVENT ENTRY FEES BEFORE CONTACTING THE REGISTRAR WILL BE MADE.**

PARTNERED EVENTS:

Only one partner will complete registration for the team. During the registration process, you will be asked to identify your partner and verify their test information. **The registered partner will be responsible for managing all aspects of the competition for the team including music/PPC upload, etc.**

FOREIGN SKATERS:

Non-U.S. skaters intending to register for this competition must set up a non-member account with US Figure Skating prior to registering for the competition ([click here for HOW TO](#)). This can be done by choosing the “Non-Member? Create Account” option on the [Members Only](#) login page.

ENTRYEEZE COMPETITION REGISTRATION:

All entries **except** Excel Series free skate events and National Solo Dance Series events will be accepted on EntryEeze with credit card only. Accepted credit cards are Visa, MasterCard or Discover. Spring Jubilee EntryEeze registration is available through www.entryeeze.com.

Registration Deadline: 04/18/2024 at 11:59 p.m. EDT (8:59 p.m. PDT)

The Chief Referee reserves the right to close registration at any time if competition entries exceed the time allotted for the competition.

Two entrants are required to hold each event. During registration, each skater competing in events that are not Excel or [NSDS Solo Dance Series](#) events will be asked the following “survey” question: “If you are the only entrant in any of your events, which of the following options would you prefer: skate the event as the only entrant, compete in an equivalent event against skaters of the opposite gender (Pre-Juvenile and lower free skate only), or withdraw from the event with a full refund of the entry fee for the withdrawn event.” Your answer to this question will be considered final and binding and will help the Chief Referee to make the schedule as quickly as possible.

An additional 3% processing fee will be added to the skater’s total at check-out to cover credit card processing fees. **Credit card processing fees will not be refunded under any circumstances.**

Skaters must include their U.S. Figure Skating/LTS member number and home club. Entry eligibility will be confirmed with the skater’s home club and coach through EntryEeze. **All competitors registering on EntryEeze must also complete the US Figure Skating online waivers available on Members Only (Waiver & Release, Medical Consent and Media Release).**

PARTNERED EVENTS:

For *partnered ice dance events, only*, each partner must register in EntryEeze separately, enter the requested information about their partner, and pay half of the event registration fee. Only one partner needs to upload music and PPC for the partnered ice dance events.

For *partnered / team Showcase, only* events, only one partner / team member will complete registration for the team. During the registration process, you will be asked to identify your partner and verify their test information. **The registered partner will be responsible for managing all aspects of the competition for the team including music/PPC upload, practice ice sales, etc.**

TEST CREDIT:

Skaters that meet the requirements for test credit may sign up for Test Credit *in the registration system (EMS / EntryEeze) in which they enter their relevant event.* There is a \$10 fee for the test credit packet. **Please include your email. Signups will not be taken at the competition. NO EXCEPTIONS. Test credit packet will be sent to the provided email address.** Skaters: Please remember that your test credit packet needs to be submitted to your home club test chair for processing.

MUSIC SUBMISSION/UPLOAD:

DEADLINE: 04/26/2024, 11:59 p.m. EDT (8:59 p.m., PDT)

All music must meet the following criteria. If you have questions about what format you have, please contact your coach and get a new version of your music that meets the criteria listed below.

- File Format: MP3
- Bit Rate: 192 kbps or higher and Sample Rate: 44,100 kHz
 - This will be verified by the music chair and they may request **that** you upload a corrected file.
- Leaders and trailers (the silence or "dead space" before and after the actual start and end of the program music) may not exceed two (2) seconds. Excessive leaders and trailers may disrupt the playing of the music during competition.

Competitors *in events other than NSDS Solo Dance Series events* must also have a backup copy of their competition music available on a cellphone or other MP3 player and it must be immediately available rink side whenever the skater competes. If the phone or MP3 player does not have the standard round (3.5 mm) headset audio port (“aux port”), an appropriate adapter, such as an Apple Lightning adaptor or USB-C adapter, that will allow the connection of a 3.5 mm headset (“aux”) plug must be provided by the skater. If needed, the phone / MP3 player should be presented to the music desk:

1. unlocked and set to never lock,
2. in airplane mode,
3. with the music queued to play,
4. with the volume turned to maximum,
5. and with sufficient charge to play the skater’s music.

The music desk will not be responsible for interruptions in the music caused by incoming calls or notifications or by insufficient battery level.

PLEASE note that the NSDS Solo Dance Series requires that competitors’ back-up music be on an audio CD. Please ensure that the backup is an audio (not a data) CD and that there is only one track on the backup music CD.

ENTRYEEZE MUSIC UPLOAD:

All competitors in events other than Excel Series events and National Solo Dance Series events must submit their music in mp3 format through EntryEeze no later than **04/26/2024 by 8:59 p.m. PDT (11:59 p.m. EDT).** **After this date, a late fee of \$50 will be assessed.** Late fees will not be removed under any circumstances and must be paid by May 3, 2024, 11:59 p.m. (PDT). If a skater has unpaid fees after that date, the Local Organizing Committee may withdraw the skater, without refund, from all entered events.

EMS MUSIC UPLOAD:

Competitors participating in events with music are required to upload their music to EMS no later than **04/26/2024 by 11:59 p.m. EDT (8:59 p.m., PDT).** **After this date, skaters will be locked out of this feature and subject to a \$50 late fee.** The late fee will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid by May 3, 2024, 11:59 p.m. (PDT). If a skater has unpaid fees after that date, the Local Organizing Committee may withdraw the skater, without refund, from all entered events.

PLANNED PROGRAM CONTENT (PPC) SUBMISSION/UPLOAD – FOR IJS EVENTS ONLY:

DEADLINE: 04/26/2024 11:59 p.m. ET (8:59 p.m., PDT)

ENTRYEEZE PPC UPLOAD: Competitors participating in any IJS-judged events must submit their PPC for every IJS-judged event in EntryEeze no later than **8:59 p.m. PDT (11:59 p.m. EDT) on 04/26/2024.** Skaters

who have not submitted their PPC by this date will be charged a **\$50 late fee**. Late fees will not be removed under any circumstances and must be paid by May 3, 2024, 11:59 p.m. (PDT). If a skater has unpaid fees after that date, the Local Organizing Committee may withdraw the skater, without refund, from all entered events.

EMS PLANNED PROGRAM CONTENT (PPC) – Competitors participating in Excel Series and National Solo Dance Series events are required to submit their PPC in EMS no later than **04/26/2024, 11:59 p.m. EDT (8:59 p.m., PDT)**. After this date, skaters will be locked out of this feature in EMS and subject to a **\$50 late fee**. The late fee will automatically be added to each skater’s cart who doesn’t meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid by May 3, 2024, 11:59 p.m. (PDT). If a skater has unpaid fees after that date, the Local Organizing Committee may withdraw the skater, without refund, from all entered events.

REFUND POLICY:

Entry fees will be refunded if no competition exists or the event is cancelled; and to entrants in an single-entry events who decline the offer to skate as outlined above. There will be no refunds for medical withdrawals. At the discretion of the LOC, if an entry is withdrawn before the close of entries, the entry fee may be returned. All requests for entry refunds must be received by the Competition Committee no later than 10 days after the 2024 Spring Jubilee Competition is held. Credit card processing fees will not be refunded under *any* circumstances.

IV. COMPETITION DETAILS

LOCKER ROOMS AND CHANGING AREAS:

Locker rooms will not be available to competitors as dressing/changing rooms at this competition. Changing in the restrooms is prohibited.

Athletes are advised to arrive at the arena ready (costumes, hair, make-up, etc.) to skate. An area to put on skates will be provided.

US FIGURE SKATING TRAVEL POLICY:

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). ON-SITE CHECK-IN, OFFICIAL WEBSITE & UPDATES:

Check-in will open one hour before the first event and run through the last event of the competition. The registration table will be located at the arena's main entrance. It is the responsibility of each competitor, parent and coach to check the official website as well as notices posted at the registration desk for any schedule changes and/or additional information pertaining to the competition. Skaters are requested to arrive 45 minutes prior to the scheduled time of their event. Starting orders will be posted 12 hours before start of competition and results will be posted online following the end of each event.

If you are participating in a role requiring compliance, please be sure to [download or print your compliance card](#) to verify your compliance status on-site, if requested. If you believe your compliance card does not accurately reflect your compliance status, please contact skatesafe@usfigureskating.org at least 2 business days prior to the competition for assistance.

SCHEDULE

Competitors may be scheduled on any day or time during the announced dates of the competition. The competition and practice ice schedule will be available after the close of entries. All participants will be notified via email once available.

PRACTICE ICE:

There is no official practice ice for this competition. Please contact [Sharks at Ice San José](#) for public or freestyle sessions time at (408) 279-6000.

AWARDS:

Medals will be awarded to 1st, 2nd, 3rd, and 4th places and will be presented as soon as possible after the conclusion of each event.

Special Award: Joan McDonnell Award (Best of Showcase Event)

Judges will recall select skaters from showcase events to compete in the Best of Showcase event. The skater with the overall highest point total in the Best of Showcase Recall will be awarded the Joan McDonnell Award. Excluding the winner of the Joan McDonnell Award, a first runner-up award will be given to each skater with the highest point total in each of the following level groupings: (1.) No Test – Pre-Preliminary levels, (2.) Preliminary – Juvenile / Open Juvenile levels, (3.) Intermediate – Senior Elite / ProAm levels, and (4.) All Adult levels. Competitors can be recalled from any showcase event: singles or duet/trio. All recalled skaters will receive a Best of Showcase medal. While Production ensembles may be recalled, they are not eligible for a Recall award.

Skaters can compete in the Best of Showcase event in only one singles showcase event. Skaters may compete a second time in the Best of Showcase only if they are recalled in a duet/trio event. If a skater is recalled in more than one singles showcase, he/she must choose which program to perform in the recall event. All previous Best of Showcase Award winners are eligible to compete again in the Best of Showcase event.

The Tony Morici Excel Award

This trophy is awarded to the skater with the highest Performance component score in the Excel Pre-Preliminary, Excel Preliminary or Excel Preliminary Plus singles free skate. In the event of a tie, the Composition score of the tied skaters will be the tie-breaker.

VOLUNTEER INFO:

We need your help. Volunteers are an essential ingredient for running our competitions and supporting our skaters. Becoming a volunteer for Spring Jubilee is easy - you can sign up at the SignUpGenius site beginning in mid-April.

Most opportunities do not require previous experience, so don't worry if you don't know how to be an ice monitor or run music. Volunteer compliance is only necessary for medical personnel (see below). Once we receive your sign-up, you will be contacted by our Volunteer Coordinator before Spring Jubilee to confirm your role and scheduled time(s).
